Policy T1(7.) refers to the delivery of a coordinated package of infrastructure improvements to junctions on the A27 Chichester Bypass; and later on to the Community Infrastructure Levy (CIL) which may be used to contribute towards the costs of improvements to the local transport network.

The explanatory text confirms that the Fishbourne Road and the Bognor Regis Roundabouts on the A27 Chichester Bypass need upgrading and that these works have the greatest priority. Both improvement schemes are recommended to be funded by developer contributions.

The upgrade schemes for these two junctions are included in the adopted Chichester Local Plan: Key Issues 2014-2029 as well as the current Local Plan consultation. It is noted that various upgrades to the A27 Chichester Bypass are being considered for inclusion in the third Road Investment Strategy (RIS3) by National Highways (NH) but NH has yet to confirm when and whether funding will be made available for the A27 improvements. As such, no detailed plans or cost information is available for these schemes at present.

In the meantime the costs of the proposed improvements to the Fishbourne Road and Bognor Road Roundabouts are to be secured from developer contributions. Paragraph 8.21 of the Local Plan Consultation quotes a per dwelling contribution of £7,728 for the southern part of the plan area (excluding the two Strategic Development Locations (SDLs) West of Chichester and at Tangmere). The developer contributions being sought for the improvements to these two roundabout junctions are from residential development and exclude contributions from retail development. This is inconsistent with CDC's adopted CIL charging schedule. No reason or justification for omitting contributions from retail developments has been given.

It is noted that the Chichester Transport Study (2023) comments that the forecast growth is likely to be lower than currently predicted within the transport model, and that the mitigation identified "may not be required in the future". Given this uncertainty, the SATURN modelling outputs cannot be relied upon to determine the

nature of any improvements that may or may not be required at these junctions. As such, the mitigation identified may not actually be required in the future.

In light of the above, the requested per dwelling contribution set out in paragraph 8.21 of the Local Consultation Plan does not meet the tests set out in the CIL regulations and is therefore not consistent with national policy.

The requested per dwelling contribution set out in paragraph 8.21 of the Local Plan Consultation needs to be clarified and based on the actual works and detailed costings for these junction improvements which are not known at present. The financial contribution being sought should also be related to the likely impact that a development will have on the junctions. For example developments on the fringes of the southern part of the plan area, such as at Westbourne, are less likely to generate traffic at these junctions and any financial contributions should reflect this.

Confirmation and clarification should also be given to existing housing allocations in made Neighbourhood Plans. These allocations should not be required to pay financial contributions towards the improvement works at these two A27 junctions as they are already planned and are in the system.
