The plan is not sound because it does not adequately consider the additional burden 1300 homes will place on the infrastructure around Saxon Meadow and the village of Tarpene which is already at breaking point and under enormous pressure. For example the roads are inadequate to deal with the existing traffic, the GP's surgery is "full" which means it is already difficult to get a GP's / Doctor's appointment - how will it cope with the additional demand? Also the access to the ambulance distribution point needs to remain clear and the amount of traffic caused by the sheer volume and number of cars without proper investment in the roads will create gridlock/congestion. In sufficient consideration of the infrastructure + investment in it to cater for the additional homes proposed means the policy is not sound. Increased traffic will impact on the quality of air. 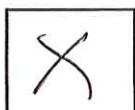
