There is "overdevelopment" as stated in the sustainability Assessment (P90) which makes the local plan not legally compliant. Tangmere Parish Council has the figure of 1156 consent houses in the village of Tangmere as a whole - it will increase the number of proposed houses (increased to 1300) is disproportionate and excessive - it will increase the number of houses in one area by over double. This is an overdevelopment, and not in keeping or sympathetic with an area which has conservation status.

Reduce the number of houses so that the density is significantly lowered and is not concentrated in one area to "dwarf" existing houses at Saxon Meadow, a conservation area and one that is next to the historical Saxon church of St Andrew's which is of national importance by virtue of being a site of commonwealth graves and its association with the battle of Brunanburh. ^{indeed the church is mentioned in the Doomsday Book.}
