ATS 7.45 recognises the A27 as the only major route East to West. The development will add to congestion without plans to upgrade the route. Plans to by-pass Arundel have already been put on hold. Tourist congestion during peak summer periods (ATS 7.50) ^{attached} make transport around the proposed development more congested.
