

Second home owners should be persuaded that many of their properties lie empty for a greater part of the year to allow them the odd weekend getaway in their rural boltholes.

Your letter to me (7th Feb) states a commitment to halt the decline of nature by 2030, and recovery thereafter. It's already too late. The climate and planet are already on a fast track to destruction. These pledges should have been acted on 30 years ago!! Words are empty, with no implementation!
