The A27 is part of the Strategic Road Network and is therefore the responsibility of National Highways. All new housing development coming forward under the Local Plan is generating additional traffic impacts on the A27 Chichester Bypass junctions and the associated local highway network. These additional impacts require mitigation **to ensure that the traffic growth associated with development in the Chichester Local Plan area to does not result in unacceptable road safety risk or is otherwise severe. This is consistent with the Governments National Planning Policy Framework. In the absence of any Government funding for improvements to the A27 corridor within Chichester,** the Council is dependent on securing financial contributions from new development to fund the necessary works.
