It is our opinion that although Bosham has been allocated a strategic allocation at Highgrove Farm ref AL7, the housing requirement for the Parish should still be increased. The land west of Delling Lane, for reference edged red on the attached plan, is approximately 7.3 hectares and can accommodate approximately 150 dwellings. The landowners are supportive of development on the site and the land is available in the early part of the plan period. The site is a logical extension to the Settlement Policy Boundary and although currently located within the AONB, this designation should not prevent development but the scheme would be designed sympathetically with the constraint in mind.
