# **Chichester Local Plan Review - Regulation** 18 Preferred Options Consultation

## **Policy S2 - Settlement Hierarchy**

- Policy S2 of the Local Plan Review identifies Chichester City as the only Sub-Regional Centre in the District. Paragraph 4.16 confirms that Chichester City will continue to develop its role as a subregional centre, and paragraph 4.89 re-iterates the fact that Chichester City is the main employment and commercial centre within the District, accounts for a high proportion of the area's local housing need, and is the most accessible location in the plan area, with the widest range of services and facilities.
- 2. Paragraph 4.13 rightly confirms that the focus for new development will be at the most sustainable locations which by definition must start with development within and adjacent to Chichester City.
- 3. Against this background, we wholly support the identification of Chichester City as the District's only 'Sub-Regional Centre', and by some distance the most sustainable settlement in the District. The development strategy for the District must, consistent with this settlement hierarchy and the principles of sustainable development, ensure that it makes full and effective use of available land in and around Chichester City before considering locating development in what are, by definition, less sustainable locations.
