## Policies Map

1. There is an inaccuracy within the plans relating to Policies S15 and AL4. As illustrated on the plan at Appendix 1, the hatched area in the south-eastern corner of the Goodwood Motor Circuit and Airfield site boundary should be removed from the line defining S15 as it does not form part of the Goodwood Motor Circuit land ownership. The landowners of the land subject to Policy AL4 confirm that his parcel of land is within their ownership.
