There appears to be confusion in the percentage provision of 4 bed plus market dwellings. The preferred approach promotes up to 20% the HEDNA 25% and the SDNP 5-10%. This issue requires reconciliation.

Para 7.7 implies that a number of larger houses will be vacated by older persons downsizing, this would only happen if such provision of suitable smaller accommodation is available, and further negates the need for more larger houses with a higher price tag and larger land take.

The ONS predicts that at least until2041 there will be a rapid rise in single person households, emphasising the effect of anaging population, and yet the CDC policy on housing mix fails to reflect the need to smaller homes and those suitable for lifetime occupation.

Object

The policy to put a minimum of 1250 dwellings in Southbourne is an outrage. This would be a more than 50% increase in the size of the settlement, and I object strongly to this proposal. Southbourne has been singled out because is away from Chichester, even though the City is not in my view taking its fair share of housing.

The Government figure of 300 thousand homes a year, has been questioned by the ONS and the figure is actually suggested to be 190 thousand homes a year, so the Council should look again at the basis for the allocation.

The SDNP has not accepted a reasonable housing figure, and the Downland villages are just the playgrounds of second home owners, away from the major settlements.

The setting of the Harbour and the Downs will be ruined forever by these proposals.

Substantial improvements to infrastructure are required in Southbourne, before any new development can be considered.

The areas that require attention include

- 1. Crossings, particularly in Stein Road and the separation of cyclists, horseriders and pedestrians.
- 2. Traffic management and flows, and integrated approach is required
- 3. Wastewater treatment the current site at Thornham requires a substantial upgrade
- 4. Stormwater discharges into the harbour.
- 5. Substantial improvements to public open space away from the harbour.
