The paragraph is not sound because the reference to a "spine road" is incompatible with Policies N22, NE20, NE23 given that the spine road connecting the A27 to Tangmere Road would cause an unacceptable increase in traffic congestion, noise pollution, light pollution, reductions in air quality and will harm health and well-being. This would harm the residents of Saxon Meadow because it will be seen and heard from their properties, in place of unrestricted views over agricultural land. At present, a very attractive feature of Saxon Meadow is stargazing and I am very concerned that this benefit will be lost through the blight caused by the new development (see photo).

10.62 The development location is situated around the western and southern edges of the village, south of the A27 and north of Tangmere Road. The site comprises approximately 73 hectares of land predominantly used for agriculture. **If housing development were to take place on this site it will be accessed from either the A27/A285 grade separated junction, or Tangmere Road to the south, but there will be no direct link between the A27/A285 and Tangmere Road to respect policies NE20, P16, NE23 and avoid this being used as a short cut, and every effort possible will be made to reduce the residual harm.**
